MERCHANT MARINE CIRCULAR MMC-407

- To:** Ship-owners/operators, Legal Representatives of Panamanian Flagged Vessels, Panamanian Merchant Marine Consulates and Recognized Organizations (ROs).
- Subject:** Welcome Guidance and Post Registration Requirements.
- Reference:** Law No. 57 of August 6th, 2008 - General of Merchant Marine.
Decree Law No. 7 of February 10, 1998.

1. Purpose:

- 1.1. The purpose of this Merchant Marine Circular is to provide guidance to users of Panama Ship Registry regarding the requirements applicable to vessels after their registration under the Panama Ship Registry.
- 1.2. It also aims to keep stakeholders informed of the various instruments adopted by the Republic of Panama concerning the registration of merchant marine vessels and other related matters. Additionally, it provides information on the applicable statutory certificates and those whose issuance has been delegated to Recognized Organizations by the Panama Maritime Authority for this purpose.

2. Scope:

- 2.1. In accordance with the provisions of item 25 of Article 30 of Decree Law No. 7 of February 10, 1998, as amended by Article 187 of Law No. 57 of August 6, 2008, one of the functions of the General Directorate of Merchant Marine is to perform Flag State functions and enforce applicable regulations on Panamanian and foreign-registered vessels operating within jurisdictional waters.
- 2.2. Such enforcement shall be carried out in accordance with national legal standards and the international conventions ratified by the Republic of Panama, particularly in matters related to maritime safety, navigational safety, maritime security, and the prevention and control of marine pollution, as well as relevant international guidelines and codes applicable to the Flag State.

2.3. The Republic of Panama has adopted several International Maritime Conventions through different national laws with the aim of preserving the safety of life at sea, preventing pollution, and ensuring the security of vessels registered under the Panamanian flag.

3. Statutory Certificates required before the vessel sails under the Panamanian flag:

3.1. The statutory certificates are divided into three segments: **Certificates issued directly by the Administration, immediate reporting to the Administration and certificates issued by the RO /Class Society.**

3.2. Once the vessel is registered under the Panamanian flag, the following statutory certificates may be required and must be requested from the Administration or issued by the corresponding Recognized Organization, as applicable.

4. Certificates that must be requested directly from the Administration:

4.1. **CSR** – Apply to vessels engaged on international voyages, passenger ships, including high-speed passenger craft; cargo ships, including high-speed craft, of 500 gross tonnage and upwards; Mobile offshore drilling units; Port facilities serving such ships engaged on international voyages. 4.2. **WRC** – Apply to vessels of 300 GRT and above. Please refer to [MMC-202](#) for further information. In case of any query on this topic, don't hesitate to contact liabilities@segumar.com and/or the nearest SEGUMAR Office (refer [MMN-018/2021](#)).

- 4.7. ISSC** – Applies to all Panamanian flagged ships engaged on international voyage of 500 gross tonnages and upwards. Please refer to [MMC-359](#) for further information. - 4.8. CTR** – Applies to vessels engaged on international voyages: all passenger ships including high speed craft; cargo ships, including high speed craft of 300 gross tonnages and above; and Mobile offshore drilling units. - 4.9. BWMP** – Applies to vessels of 400 GRT (except vessels, floating platforms, FSUs, and FPSOs at the location and Art. 3.2a & 3.2f BWM convention). - 4.10. IBWMC** – Applies to vessels of 400 GRT and above (except vessels with ballast tank sealed, floating platforms, FSUs, and FPSOs at the location of operation and Art. 3.2a & 3.2f BWM convention). - 4.14. Other certificates issued by the Administration if the vessels are subject to some especial conditions allowed by the international instruments and the national legislation are:**

4.15. In addition, this Administration has established a series of letters that might be issued in different scenarios and circumstances, such as Authorization, Concurrence, Dispensation, Statement, and Acknowledgement letters for different purposes.

5. Immediate reporting to the Administration:

5.2. **CSO** – Applies to all Panamanian flagged ships engaged on international voyage of 500 gross tonnages and upwards. Please refer to [MMC-123](#) for further information. 5.3. **MLC financial securities (DMLC)** – Applies to all vessels with personal consider Seafarer (according to STCW Code). Please refer to [MMC-269](#) for further information. 6. Issuing Certificates by Recognized Organizations (ROs)

6.1. **Certificates** not issued by the Flag State, users of the Panama Ship Registry are free to contact any of the Recognized Organizations approved by this Administration, listed in Merchant Marine Circular [MMC-136](#). These ROs provide essential services related to survey, inspection, and audit processes, as well as the issuance of statutory certificates. By selecting the name of each RO, users will find more detailed information about the certificates they are authorized to issue.

10. Requirements applicable for the registration under the Panamanian flag of vessels engaged in fishing, cabotage and domestic service with a gross tonnage below 300 and/or 500 gross tons:

- 10.1. Vessels engaged in fishing, cabotage and domestic service activities with a gross tonnage below three hundred (300) and/or five hundred (500) gross tons, applying for registration under the Panamanian flag, shall comply with the registration, inspection, safety and certification requirements established by the Panama Maritime Authority, through the General Directorate of Merchant Marine.
